

ST. FRANCIS SCHOOL - ELLSWORTH, WI

Our cost per student for 2017-2018 was approximately \$7,700. Income from tuition and from Home & School Association fundraising contributed approximately \$2,000 per student. This left a balance of \$5,700 per student for our parish to pay. The following tuition rates are possible only through the generosity of the members of St. Francis Parish. If you consider yourself to be a member of St. Francis Parish in order to qualify for the reduced tuition rate, you are claiming that your family attends Mass, and makes a financial contribution on a weekly basis through the envelope system to help support the needs of our parish and school.
